1. Purpose of Report

3 Background

3.1 This report is set within the context of decisions made on the way the Council is structured to conduct business at Area/ Ward/Neighbourhood levels as agreed in the following Cabinet Reports: - Cab. 10.10.2012/6; Cab.21.11.2012/6; Cab.16.1.2013/10.3; Cab13.2.2013/9 and Cab.8.5.2013/7.1.
