#### 3 URGENT ITEMS

Councillor Fox referred to a number of pension related emails in relation to South Yorkshire Fire and Rescue Service's employees, and sought answers in relation to the deficit.

The Chief Fire Officer referred Members to a letter he had received from A Cornelius, Head of the Firefighters' Pension Scheme, dated 3 July 2014, which was a direct response to an enquiry regarding the implications of Close Proximity Crewing (CPC) and the Pension Scheme. A Cornelius had stated that, even if the Service introduced CPC at all five of the proposed stations, the impact upon the Pension Scheme would equate to 0.06% which was negligible, not least as firefighters would begin to move towards career average schemes from next year.

A Frosdick commented that CPC would be taken as an urgent item, and would be discussed in the private section of the meeting.

#### 10 SOUTH YORKSHIRE JOINT SECRETARIAT - INTEGRATION

A report of the Clerk to the Fire and Rescue Authority was submitted to inform Members of the progress made to date in integrating the support arrangements to the South Yorkshire Joint Authorities with Barnsley MBC acting as lead authority on behalf of South Yorkshire partners.

Members noted that the Joint Secretariat Management Board had given approval at its meeting on 26 September 2014, to the proposed integrated arrangements to support the Joint Authorities directly through Barnsley Council acting as lead authority, and proposed that the Joint Authorities be recommended to formalise the arrangements with effect from 1 April 2015. As a result, a review of the future role of the Joint Secretariat Management Board would be undertaken, and the South Yorkshire Joint Secretariat as a "Brand" would formally cease.

Members agreed that a Service Level Agreement (SLA) was necessary, to provide reassurance to the public that the Authority was getting value for money.

A Frosdick commented that a SLA would shortly be produced and would specify that the Authority would continue to receive the same level of service it had received historically; Members would also be asked what additional services were required. The Chair pointed out that any additional services would mean increased costs.

Councillor Bosmans requested that Members had the opportunity to scrutinise the SLA within 6 months to 1 years' time.

Councillor Buckley suggested that the SLA be submitted to the Scrutiny Board meeting on 13 November 2014; all Members would be invited to attend the meeting to discuss the item.

#### RESOLVED - That Members:-

- Approved the proposed arrangements to establish Barnsley as Lead Authority to provide relevant support services to the Authority with effect from April 2015 and that the relevant formal agreement between the Council and the Authority be amended.
- ii) Received the accounts and related reports for the financial year 2014/15 and consideration be given to the future of the Joint Secretariat Management Board.
- iii) Agreed that all Members be invited to the Scrutiny Board Meeting on 13 November 2014 to discuss the SLA.
- iv) Agreed the SLA be brought back to the Authority meeting on 24 November 2014 for final approval.
- v) Agreed to scrutinise the SLA within 6 months to 1 years' time.

## 16 CONTROL COLLABORATION PROJECT (CCP) UPDATE

A report of the Chief Fire Officer and Chief Executive and Clerk was submitted to provide the Authority with the quarterly update on the progress of the joint Control Collaboration Project which was being undertaken in conjunction with West Yorkshire Fire and Rescue (WYFR).

Members were informed that the South Yorkshire element of command and control went live on 7 October 2014; it was anticipated that West Yorkshire would go live in November 2014.

#### Members noted that:-

- Data cleansing, migration and manipulation was now complete.
- There was one outstanding training issue in relation to bolt-on systems i.e. Geo-Concept.
- A number of minor developments were currently underway in relation to ICT.
- The South Yorkshire element of Project Builds/Delivery was complete; the "fall-back" room had been handed over to West Yorkshire Fire and Rescue.
- The joint Ways of Working Team continued to look at "synergies" across each service, and were examining how to further enhance joint ways of working.

Councillor Bosmans was encouraged by the way people had pulled together to work on the project, which had been delivered on time and to budget; he suggested the project be rolled out to other fire and rescue services who were interested in the scheme, to work alongside SYSTEL.

RESOLVED – That Members noted the progress of the project to date.
