2014/0372 and 2014/0587 – Formation of a raised garden area (retrospective), raised decking and screen fencing and remedial landscaping works to embankment – 20 Ladyroyd, Silkstone Common.

### 35. <u>Town and Country Planning Act 1990 – Part III Applications</u> <u>Speakers/Site Visits</u>

 Mr P Thornton (Agent) addressed the Board and spoke in favour of the Officer recommendation to approve Planning Application No 2014/0474 – Erection of 301 dwellings with associated public open space, landscaping, access, parking and ancillary works – Land North of Wilthorpe Road, Redbrook.

RESOLVED that the application be approved in accordance with Officer recommendation, subject to-

- (a) Section 106 Agreement with an amendment to Condition 9 for the provision of a roundabout in place of a right turn lane;
- (b) consultation with Education to consider utilising some of the Sustainable Transport Contribution to benefit walking and cycle routes to local schools as part of the Section 106 Agreement; and,
- (c) the position of the LEAP be assessed to ensure it is well placed and not near to the road.
- Mr J Powers (Objector) addressed the Board and spoke against the Officer recommendation to approve Planning Application No 2014/0372 Formation of a raised garden area (retrospective) raised decking and screen fencing 20 Ladyroyd, Silkstone Common.

**RESOLVED** that the application be refused against Officer recommendation on the grounds of the overbearing impact on neighbouring properties and inappropriate encroachment into greenbelt land.

**2014/0454** – Demolish existing derelict building and replace with a new dwelling – Scout Dyke Reservoir, Huddersfield Road, Penistone.

**2014**/**1019** – Erection of ball stop fencing – King George Park, Tinker Lane, Hoyland Common.

### 37. Extinguishment of Footpath Nos 68 and 69 Barnsley between Bakewell Road and Matlock Road, Athersley

The Assistant Director, Highways, Engineering and Waste Management presented a report for consideration to:-

- (a) rescind a previous approval of the Planning Regulatory Board (Minute No 10 – 24 June 2014), which approved the extinguishment of Public Footpath No 68; and,
- (b) extinguish the same path previously considered and the extinguishment of an additional footpath, No 69 Barnsley.

#### **RESOLVED** that:-

- (i) the decision recorded in Minute No 10 at the meeting of the Planning Regulatory Board on 24 June 2014 be rescinded;
- (ii) in exercise of Statutory Powers, the Council makes Public Path Orders under the provisions of Section 257 of the Town and Country Planning Act 1990 and Section 118 of the Highways Act 1980, for the extinguishment of the Public Footpaths shown on the plan attached at Appendix A to the report;
- (iii) the Common Seal of the Council be affixed to the Orders and that the Director of Legal and Governance be authorised to publish the proposal and to submit the Orders for confirmation by the Secretary of State or to confirm them himself in the event of there being no objections thereto; and,
- (iv) in the event the Orders are confirmed, the Director of Legal and Governance be authorised to make a Definitive Map and Statement for the area.
