90. Minutes

The minutes of the meeting held on 25th September, 2014 were taken as read and signed by the Chairman as a correct record.

91. Communications

(a) Ofsted Inspection – Improvement Notice

The Chief Executive was delighted to inform Members of the Council that the Improvement Notice, which had been placed upon the Council by the Department for Education following an Ofsted Inspection of the Authority's Social Care and Looked After Children's Services in November 2012, had been lifted with immediate effect.

This was a huge achievement and was testament to the effort of all staff and Councillors who had been involved in this process. There had been a huge step change in the way in which services were provided and decisions made and thanks were extended to Rachel Dickinson, Executive Director, Children, Young People and Families and to all staff and Members for their hard work, professionalism, dedication and support in achieving this outcome.

Councillor Tim Cheetham, Cabinet Spokesperson for People (Achieving Potential) asked to place on record his personal thanks at this achievement which, he felt, should not be underestimated . He commented that to achieve this improvement within 23 months was a testament to the hard work and dedication of all staff, Members and Partnership organisations. Particular thanks were extended to Rachel Dickinson, Jane Haward (Chair of the Ofsted Improvement Board) and Bob Dyson (Chair of the Safeguarding Children Board). Councillor Bruff, Cabinet Spokesperson for Safeguarding, asked to be associated with these remarks.

The Mayor and Members of the Council expressed their thanks and appreciation to all involved in the usual manner.

(b) Silkstone Common Junior and Infant School

The Chief Executive was pleased to inform Members of the Council that the Sunday Times had recently published a table of the top 200 state primary school in the country. Silkstone Common Junior and Infant School had been placed at No 11. This made the school the best primary school in Yorkshire which was a fantastic achievement for all pupils, staff and Governors.

The Mayor and Members of the Council expressed their congratulations to all concerned in the usual manner.

(c) Cooper Gallery Heritage Lottery Fund

The Chief Executive reported that the Cooper Gallery was celebrating its Centenary this year and it was pleasing to report that it had been awarded a grant of £638,000 by the Heritage Lottery Fund towards the cost of extending and improving the Gallery further.

The Council was very proud of its relationship with the Gallery Trustees on whose behalf the Authority run the Gallery. Thanks were extended to the Trustees for their hard work and vision and congratulations were extended to them on this success.

Paul Elmhirst, Chair of the Trustees, was in the Council Chamber this morning together with Lynn Dunning, Natalie Murray and Jane Galvin from the Council's Culture Team who had worked tirelessly in securing funding for this project.

Councillor Bruff, Cabinet Member for Safeguarding, asked to place on record her personal thanks to all concerned at this achievement and reminded Members of the Council that the Gallery was one of the 'jewels' in Barnsley's crown.

The Mayor and Members of the Council expressed, in the usual manner, their congratulations to all involved in this achievement.

(d) Animation Awards

The Chief Executive was delighted to announce that the Youth Panel at the Experience Barnsley Museum had been nominated for several awards for their animation films Lego Heist: Barnsley Museums and Women of the Working Class which had been playing in the Chamber this morning prior to the meeting.

Councillor Miller, Cabinet Spokesperson for Place commented that Lego Heist had been nominated at the 2014 Bradford Animation Festival Award for Best Commissioned film and the film Women of the Woking Class had won the British Film Industry Kids for Kids Award, Best Mixed Media (14-17 years) Class at the International Family Film Festival in Hollywood and had gained third place at the My Hero International Film Festival in Santa Monica, California. This meant that these films had gained both national and international recognition which was a significant achievement. He reminded Members that Women of the Working Class was an animated short film made by young women from the Youth Panel to mark the 30th anniversary of the 1984/85 Miners' Strike. The film was based on the research the Panel had gathered on the women against pit closures movement and was created from their own drawings, objects featured in the Women Against Pit Closures exhibition and Lego Characters. It had been made with support from Aardman Storyboarder David Bunting (who usually worked on Shaun the Sheep and Chuggington) and was funded by the Arts Council Museums and Schools Programme.

Mr Bunting was to be commended for his ongoing support and commitment to Barnsley and its young people, both in producing work of such high quality and in designing the successful after school programme. He also wanted to acknowledge the work of Jemma Conway, Community Heritage Curator and May Redfern for their support on this project with the Youth Panel.

India Sedgewick, who had interrupted her studies, was in the Council Chamber this morning representing her fellow 'movie makers' who were commended on their achievements.

The Mayor and Members of the Council expressed their congratulations to all concerned in the usual manner.

(d) Chief Superintendent Andy Brooke

The Chief Executive informed Members of the Council of the retirement of Barnsley's Chief Superintendent Andy Brooke. Andy had been the District Commander in Barnsley for the past 7 years overseeing ongoing reductions in crime and anti-social behaviour rates in the Borough and maintaining Barnsley's envious position as the safest town in South Yorkshire. He had returned to his roots and hometown in Barnsley after an illustrious career throughout South Yorkshire which had commenced 35 years ago as a cadet and rookie Police Constable walking the beat in Goldthorpe.

He had been a true stalwart of neighbourhood policing and working in partnership with the Council and had been central to maintaining a Barnsley focused approach to District Policing. He had a genuine passion for ensuring that Barnsley's residents had a significant voice in determining their local priorities and had been a huge advocate for working closely with the Council to deal proactively and intelligently with the needs of the community.

Chief Superintendent Brooke had contributed significantly to the strategic leadership of the town successfully chairing both the Drugs and Alcohol Action Group and the Community Safety Partnership and being an enthusiastic member and contributor to the One Barnsley Partnership and Health and Wellbeing Board. His leadership within the Police Force was legendary and resonated across all ranks and his commitment to frontline services had been epitomised by his keenness to don the uniform and accompany his frontline staff on the streets at times of real pressure.

He had been a true ally to the Council and had helped to cement the relationship between the Council and the Police at all levels. He would be a hard act to follow.

Councillor Sir Stephen Houghton CBE (Leader of the Council) and several other Members asked to place on record their appreciation to Chief Superintendent Brooke for his contribution to the safety of the Borough's residents and his enthusiasm for working with the Council to tackle the problems throughout the area.

The Chief Superintendent was then given a presentation by the Mayor of an engraved bowl to mark his retirement which bore the following citation:

'Presented to Chief Superintendent Andy Brooke on his retirement from the South Yorkshire Police to mark our appreciation of his hard work and dedication to the people of Barnsley, November, 2014'

The Mayor and Members of the Council extended, in the usual manner, their best wishes to Chief Superintendent Brooke for a happy and health retirement and gave him their best wishes for the future.

92. Questions by Elected Members

The Director of Legal and Governance, on behalf of the Chief Executive, reported receipt of a question received from Councillor Hand-Davis in accordance with Standing Order No.11.

'Could Members of the Planning Regulatory Board be given authority to allow local Ward Members to speak at meetings of the Planning Regulatory Board'

Councillor Miller, Cabinet Spokesperson for Place responded by stating that the Council's Planning Code of Conduct, which had been introduced in 2004, amended Standing Orders to expressly provide that Elected members who were not Members of the Planning Regulatory Board were not permitted to speak at meetings of the Board. The Code had been considered by the Standards and Probity Board prior to it being recommended to the Council. The changes were influenced by the importance of establishing clear accountability for who was responsible for making decisions on planning applications.

However, given that it was some 10 years since the Code had been introduced, he was more than happy to ask officers to re-examine the document in consultation with himself and the Chair of the Board giving due consideration to the current legislative requirements and the increasing localism agenda which had assumed an increasing significance since 2004.

A further report would be presented so that the relative merits of the alternative approaches of the issue could be given proper consideration.

Councillor Hand-Davis welcomed this approach and commented that this issue had arisen due to a number of particularly contentious planning applications being submitted. He asked, therefore, as a supplementary question, whether consideration could be given to the adoption of an approved protocol perhaps requiring written consent for permission to speak.

Councillor Miller welcomed any suggestions and asked Members to let him have any suggestions so that all options could be considered prior to the submission of a report.
