(iii) Mr L Searles (Agent) addressed the Board and spoke in favour of the Officer recommendation to approve Planning Application No 2014/0559 – Erection of a renewable energy park comprising of a timber resource recovery centre and anaerobic digestion facility – Land off Houghton Main Colliery Roundabout, Park Spring Road, Great Houghton.

RESOLVED that the application be refused against Officer recommendation on the grounds that the harm to landscape character, visual amenity, openness of adjacent greenbelt and highway safety, would outweigh the merits of the proposal.
