271. <u>Corporate Spokesperson – Disclosure and Barring Service (DBS) Policy</u> (Cab.22.4.2015/7)

RESOLVED that approval be given to implement the changes to the Disclosure and Barring Service (DBS) Policy, as detailed in the report now submitted.

272. <u>Place Spokesperson – Proposed Demolition of 1-37 (Odds Only) Beever Street, Goldthorpe (Cab.22.4.2015/8.1)</u>

RESOLVED:-

- (i) that authority be given to enter into negotiations with property owners at 1-37 Beever Street, Goldthorpe to acquire properties for the purposes of clearance and re-development. Property owners and any qualifying tenants will be eligible for compensation in line with the Land Compensation Act 1979, plus a disturbance/enhanced disturbance payment in line with existing decant policies;
- (ii) that the Council offer a compensation package to property owners (not residing at the property as their main or principal homes e. g. a landlord/Investor) which is consistent with compensation offered via a Compulsory Purchase route market value plus 7.5% as a "home loss" payment;
- (iii) that the Council gives authorisation to pursue acquisition via a Compulsory Purchase Order (CPO), should acquisition via negotiation not be possible;
- (iv) that £1m Empty Homes Cluster Funding (£1m, which is the BMBC match element of the Department for Communities and Local Government (DCLG) bid via the Housing Capital Programme approved via Cab.23.5.2012/9.2) be ring-fenced to the acquisition and clearance programme at Beever Street;
- (v) that 2015/16 funding available for Empty Homes Grants (under the DCLG Goldthorpe Clusters Programme) be prioritised to assist property owners wishing to accept a Property Swap in lieu of the property ring-fenced for clearance, the grant to be made available for repairs and improvement works ONLY, and not to bridge any shortfall in property values between an existing and potential property swap dwelling; and
- (vi) that to improve the housing offer and wider environment in and around the central Goldthorpe area in the long term, further consideration be given to pursuing additional property clearance and redevelopment within this area of Central Goldthorpe.
