P Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

All staff both voluntary and ppaid are trained to the expected requirement to fullfill their tasks at the event safely and competantly. We have held the event in Barnsley for four previous years, on two locations, and have experienced no problems with licensing either from objection or infrngment of the license. The event will be an over 18's event with alcohol being provided by a licensed bar onsite Access to the site will be controlled by security who will monitor numbers and prevent alcohol being taken on or off site. A zero tollerance approach to illegal substances will be implemented at the festival.

b) The prevention of crime and disorder

Adequate security for the event is to be provided by Rock Steady Security Ltd. Who will liase with the police closley prior to the even. Alcohol will be available for consupmtion on the premises with eight S.I.A registered doormen being provided by Top Team security. Bom will invite the police to stakeholder meetings and will action any advice given. A direct number for the police has been provided and they are aware of the details of the festival. At the end of the event. Bom encourage good behaviour by closing the festival with an anouncement over the P.A. People who approach the bar whilst innebriated will be refused a drink and anti social behaviour will not be tolarated. Any instance of criminal activity discovered by our staff will be reported to the police.

c) Public safety

A traffic strategy is to be implemented on the day and refuse will be cleared from the site through out the event. A risk assesment of the site will be complied. All staff both voluntary and paid are trained to the expected requirement to fulfil their tasks safley and competantly. SIA registered security will be provided for the licenced area. Adequate first aid cover will be supplied by E.R.T and the emergency services have been consulted prior to the event. Bom has a Health and Safety officer who periodically check the site and performance areas for hazards. Accidents will be recorded in a an accident book. A perimeter fence will allow us to control numbers onsite (max 2500) but will allow access to the emergency services through a gate in the fence. Plenty of free water is available.

d) The prevention of public nuisance

All the festival Promotion will advice on good behaviour. A letter informing residents of the festival will be compiled and delivered by us. A public meeting with local residents is to be organised in conjunction with the local councillors. The police are in attendance when the festival closes which encourages civil order and speedy dispersal of the public. All P.A systems are directed in accordance with enviromental health guideline. The site will be cleared of all refuse and left as we found it.

e) The protection of children from harm

A child Protection policy is in place for the event and is complied in conjunction with the youth service. All children will be cleared from the site by 19.00 hours if not accompanied by an adult.


