





Community Safety Officer Report

The Locality 3 Team (BMBC Safer Neighbourhood Service) covering The Dearne / Hoyland Darfield and Wombwell has received 230 jobs directly from Triage and Assessment between October 1st and December 31st - the bulk of this being environmental related complaints. In addition, work has also been proactively generated and has also come into the system through police colleagues and other departments. The actual number of calls/emails into Triage for the whole of the South totalled 502 and was divided as follows:






Those jobs not filtered directly through Triage to the Community Safety Team Leader were either generated proactively (Private Sector Housing and Enforcement staff) dealt with at triage stage (priority levels 0 and 1) or sent straight through to the Case Management Team (priority level 4). Figures suggest that the current system is working in terms of ensuring that medium level (2/3) priority jobs are coming straight into the locality team.

In addition to work carried out alongside the Local Policing Team and other agencies (Berneslai Homes / Social Care / FIS etc.) the following jobs were triaged and assessed through to the Community Safety Team Leader who worked jointly with the LPT Sgt and other officers to deal with these complaints.





- One Community Protection Warning Notice has been served.





Private Sector Housing and Enforcement Officer Report

During the months October to December, 2017, the PSHEO dealt with **184** complaints, queries and requests for service, advice and referrals. These include information/intelligence passed onto South Yorkshire Police.

Housing Disrepair.

18 housing issues within Quarter 3 broken down as follows:

- **8** general disrepair, (these ranged from uneven floorboards to damp and mould and vandalised properties
- 8 premises open to access.
- 1 Defective Guttering.

Landlords/Letting Agents were contacted in relation to each one of these were dealt with on an informal basis without the need for Formal Notices being served.

1 Alleged overcrowding. I have visited the property on a number of occasions but there has been no one available. This property will be monitored.

Waste on Premises.

54 Waste on Premises within Quarter 3. Occupiers/tenants spoken to or informal waste letter was sent asking for the waste to be removed within **14** days. Of these **49** complied and **5** were served with CPN Written Warnings. Of these 5, 3 complied with the warnings and the remaining 2 were served Community Protection Notices. These expired at the end of December. Visits to be made to see whether or not the Community Protection Notices have been complied with if they have not then FPNs will be issued.



Dog fouling in gardens.

11 dog fouling in gardens. Occupiers/tenants spoken to or informal letter was sent asking them to remove the dog faeces. These all complied.

<u>Bins.</u>

16 domestic recycling bins were identified as containing contaminated waste and email sent to Waste Management requesting lifting and removal of the bins.

Fly tipping.

In total **42** fly tipping cases were found during routine proactive visits within Quarter 3. Where items of waste have been fly tipped and no evidence has been found, email was sent to Neighbourhood Services along with photographic evidence requesting the waste be removed.


42 referrals made to Neighbourhood Services hence no evidence contained within any of the tips.

Letters delivered regarding fly tipping/littering.

Request received from Dearne Area Team asking if the PSHEO could produce and deliver letters to residents with regard to fly tipping and littering within 2 key locations within the village.

49 Letters were delivered to properties on one Particular Street in Goldthorpe regarding litter. This street does have a problem with litter, letters are occasionally delivered informing residents of their responsibilities when disposing of food, wrappings etc.

30 Letters were delivered to properties on another street in Goldthorpe regarding fly tipping on the railway embankment. Letters are occasionally delivered reminding residents of their responsibilities when disposing of waste etc.



The SNS 'out of hours' team has continued to conduct patrols conducted within The Dearne this quarter. These jobs include the following;

- Visiting victims to offer reassurance
- Visiting perpetrators
- Patrols in areas where ASB has been reported
- Delivering ASB surveys
- Community engagement events.

Victim and Witness Support Officer Figures

- 8 new referrals / 27 cases in total
- 7 of the new referrals were in the Dearne area and 2 additional cases continued from the last quarter
