# **LICENSING ACT 2003**

# APPLICATION FOR A PREMISES LICENCE Taco Bell, Rockingham, Kestrel Way, Birdwell, Barnsley

# 1 Background

- 1.1 On 15 May 2016, a valid application under the provisions of the Licensing Act 2003 was received from John Gaunt & Partners on behalf of Northgate Fast Food Limited, 1<sup>st</sup> Floor, Kirkland House, 11-15 Peterborough Road, Harrow, Middlesex HA1 2AX. A copy of this application is attached as Appendix 1.
- 1.2 Members are requested to determine the application for a premises licence.
- 1.3 The proposed premise will be located amongst business dwellings of a similar nature and within relatively close proximity to a residential area.

# 2 Application for Premises Licence

2.1 The proposed application requests the licence takes effect as soon as possible and requests the following licensable activities and opening times:

# a) Late Night Refreshment

Monday to Sunday 23.00 - 03.30 indoors/outdoors

\*Where hours for sale of alcohol are extended hereunder these hours are also extended

# b) Supply of Alcohol

Monday to Sunday 10.00 – 03.00 both indoors/outdoors

\*New Years Eve: 10.00 to New Years Day – terminal hour as proposed

# c) Opening Times

Monday to Sunday 09.00 to 03.30

\*The premise will close 30 minutes after the end of the non-standard timings identified above.

# 3 Promotion of Licensing Objectives

3.1 The applicant has set a number of steps intended to be taken in order to promote the four licensing objectives, as set out in Section M of Appendix 1.

# 4 Responsible Authorities

- 4.1 A representation has been received from Mr Paul Whittington, Trading Standards Officer as a Responsible Authority involved in this process. A copy is set out in Appendix 2.
- 4.2 Mr Whittington has objected to the grant of the licence on the grounds of crime and disorder and the protection of children from harm.
- 4.3 In a bid to address concerns raised in respect of the provision of alcohol and potential underage and proxy sales, Mr Whittington has proposed a number of conditions to be attached to the premise licence, as set out in Appendix 3.
- 4.4 At the time of writing this report, Mr Whittington has not received a response in relation to proposed conditions.

# 5 Interested Parties

5.1 Following publication of the statutory notice of the application for the premises licence in the local press and the display of notices at the premises, no representations have received.

# 6 Compatibility with the European Convention on Human Rights

The decision of the panel will amount to a determination of the Council and the rights of the applicant. Therefore, as far as it is possible to do so, the panel must comply with the requirements of Article 6 (the right to a fair trial). This means the applicant and should be afforded the right to make oral representations at the meeting.

If Members determine to refuse the application, it is necessary for the reasons to be clearly stated.

This is a redevelopment site for which no rateable value has been fixed attributable to our clients proposed development of the site as a Taco Bell. Accordingly, a Band C fee is payable. The proposal is to develop the site as a Taco Bell restaurant including external seating areas as shown on the plans deposited with the application and a drive thru facility.

The Licence is sought to allow the sale of alcohol for consumption on or off the premises with a meal or for consumption off the premises ancillary to a takeaway meal ordered from the premises with a "drive thru" facility.

The proposed permitted hours for licensable activities for these premises are as follows:

- 1. Sale of alcohol for consumption on and off the premises 10:00 to 03:00 hours, seven days a week.
- 2. Late night refreshment from 23:00 to 03:30 hours seven days a week.







Good Morning,

I've been through the application and have a number of concerns, the application in general appears to be a copy and paste with little or no regard to the specifics of the premises.

In the General box in relation to all four licensing conditions that application states that Records of Training will be made available for inspection by the police or officers of Sheffield City Council. I would ask that records be made available to officers of Barnsley Metropolitan Borough Council too.

Under prevention of crime and disorder the application states "The premises shall operate a proof of age scheme and will require photographic ID from any person who appears to be under the age of 21 (Challenge 21)" Taken at face value this appears to be saying that no one under 18 will be admitted to the premises, is this correct or is this a result of the copy and paste approach?

Again under prevention of crime and disorder we have "CCTV to cover the main entrance" the activities proposed at these premises will mean that it is not necessary to use the main entrance to be supplied with alcohol or late night refreshment at the premises. I would suggest that the whole of the licensed area be covered including the drive through area.

Again under prevention of crime and disorder, "There shall be no drinks promotions at the premises which are inconsistent with the need to promote responsible drinking" I would question whether serving alcohol in open containers to drivers is consistent with the need to promote responsible drinking. The consumption of alcohol whilst driving is not in itself an offence however it is widely seen as irresponsible. Alcohol Concern in their report "On the Road – Alcohol and Driving" published in 2013 reported that in the USA where the majority of states have laws preventing open containers being carried in the passenger compartment a study had demonstrated those who did not restrict the carrying of open containers in the vehicle "experience a significantly greater number of fatal crashes in which alcohol plays a part".

Drink driving is now seen as a significant social taboo, those who engage in it are viewed with contempt even if they are not committing an offence. A recent press report concerning this very matter demonstrates that the Police and the national press consider the actions newsworthy.

This issue may be compounded by the issues in the surrounding area with anti social behaviour. Anti social behaviour has long been a concern in the area, particularly in relation to the activities of "boy racers" on Dearne Valley Parkway and at Cortonwood retail park. In particular ASB in this area was a priority for Rotherham North SNT from 2012. The area was again a priority in 2015, with SYP advising they would be monitoring the area. In March this year barriers were installed at Cortonwood in an attempt to deal with the anti social behaviour following the intervention of Jon Healey MP. Whilst this may improve the situation at Cortonwood it runs the risk of pushing the problem elsewhere. With the premises being sited only a few miles away and on the Dearne Valley Parkway, part of the problem area, I have concerns that this premises would be a magnet for similar behaviour.

This combined with the availability of alcohol to drivers would appear a potentially very dangerous combination. There is no recognition of the situation in the area surrounding the premises in the application including no suggestion of any attempt to mitigate against the gathering of groups of "boy racers" as has been seen a few miles up the road and as has been implemented at other premises of a not dissimilar nature within Barnsley.

Under the protection of children from harm the application states "There shall be adequate controls in place including staff training to safeguard against the sale of alcohol to persons under 18" but gives no indication of what they are. Again the specifics of this site will call for a different approach to that found in 99% of premises. The practicalities of preventing underage sales will be significantly different at the drive through to in a normal retail or restaurant situation. There is nothing in the application as to how age verification would work in a drive through scenario. At the time of ordering the server will not have a line of sight to the person ordering or an ability to verify their age. It is also not clear when the decision on serving will be made i.e. at the point of ordering or at the point of delivery to the customer.

There is also nothing in the application concerning proxy sales. The applicant has said that they will have a challenge 21 scheme. The RASG developed and operated the Challenge 21 scheme (which has since become Challenge 25) and in their "Guidance for Responsible Retailing" it states that responsible retailers "implement further voluntary measures to prevent underage and proxy sales" however there is no reference to how this will work either by way of policy or the practicalities of it. In combination with the well documented issues of anti social behaviour at Cortonwood which may spill over to this premises I would suggest there is a higher than usual risk of proxy purchasing.

Given these issues I would suggest that it is not appropriate to supply alcohol from the drive through window at this premises. I'd suggest that anyone wishing to purchase alcohol be required to enter the restaurant area to allow the purchase to be made in a more controlled environment and to allow the usual process of age verification to be carried out.

That these issues have not been addressed and that the application is a word for word copy of the application for the Taco Bell on Peel Street would suggest that no consideration has been given to the specific circumstances concerning this premises and the difficulties they pose. The fundamental differences being the location and its drive through facility.

I have contacted North East Lincolnshire Council's Licensing department as I am aware that they received a similar application last year however I am yet to receive a response. Regards,

Dear Mr Shield.

I have heard back from North East Lincolnshire Council in relation to the Taco Bell Drive Through Restaurant in Cleethorpes.

They had similar concerns about the application when it was received, the situation was resolved with the applicant agreeing implement additional conditions. If these or similar conditions were adopted it would address my concerns regarding the irresponsible provision of alcohol and the issues surrounding the potential for underage and proxy sales.

- There will be no sale or supply of alcohol via the drive thru facility.
- Alcohol will only be sold to a person purchasing food and ancillary to that food.
- For the purchase of multiple alcoholic beverages (maximum of 4), all persons due to consume such alcohol must be present for the transaction and present identification if required. Otherwise, alcohol is limited to one bottle of alcoholic beverage per customer per transaction.

In addition I'd ask that you consider adopting the following conditions in relation to the outside areas marked on the plan.

- The premises licence holder shall provide and maintain in good working order a CCTV system providing effective coverage of the whole of the area (both internal and external) which is under it's control.
- The premises licence holder shall erect signs on the premises, both internal and external (as appropriate) advising that the premises is covered by CCTV, that the car park is for use of patrons only, that engines shall not be left running whilst vehicles are stationary and that music systems shall be switched off.
