

#### Section 106 Allocations Darfield Cricket Club

- 1. Purpose of report
- 1.1 This report seeks approval for the allocation of Section 106 monies as set out in the recommendations section of this report.
- 2. Recommendations
- 2.1 It is recommended that:

#### 3. Introduction

3.1 This report relates to monies totalling £15,000 in the form of a Public Open Space Contribution which have been received from the S106 Legal Agreement relating to planning application 2015/1302 Former Highfield Grange, Wombwelll. The defined spend condition contained within this legal agreement is specified as:

"the provision of and/or improvement to public open space in Wombwell or Darfield" (2015/1302)

- 3.2 The proposed allocation will enhance and provide long term sustainability of a much used community asset within the local area. The proposal is therefore deemed to be compliant with the terms of the legal agreement.
- 3.3 The proposals contained within this report are also deemed to compliant with the CIL Regulations to be adopted 1<sup>st</sup> April 2015 where no more than 5 legal agreements can be pooled to fund site infrastructure. S106 allocations to the site contained within this report on or after 6<sup>th</sup> April 2010 are shown in Appendix B of this report.

#### 4. Consideration of alternative approaches

**4.1** This report has been prepared within the agreed protocols established for the progression of S106 related projects within the Council.

#### 5. Proposal and justification

- 5.1 Darfield Cricket Club is looking to purchase an outdoor 2-lane training area for their ground located on School Street, Darfield. This will be an all-weather facility surrounded by netting and a cage. Anticipated costs are around £30/£35K. Once in place the training facility can be used not only by the Club but also by local schools.
- 5.2 The Cricket Club already has an established relationship with Upperwood Academy which holds its cricket days / sports days at the facility during the warmer months and is in the process of building relationships with Outwood Academy, Darfield All Saints and St Michaels All Angels by arranging for their head Coach to go into the schools to offer talks about the sport and encourage take up of the facilities on offer and cricket in general.

- 5.3 An application is being worked on into the Sport England Community Assets Fund for £20K the Club is looking to source match funding for this application of approx. £10K/£15K from Section 106 monies. The Sport England Fund is being awarded from February 2017 and the Club is looking to have the 2-lane training area installed April / May 2017.
- 5.4 It is believed that this project would enhance the Club as a Community Asset and allow them to do more around coaching and getting more children involved by way of offering additional sessions during the summer months and school holidays.
- 5.5 There is an offer from the Club to get their young cricketers involved with wider community activities and events.
- 5.6 The Cricket Club currently has a Management Committee of 10 regular volunteers (sometimes more) and 6 volunteer coaches. There is also one paid lead coach who acts a mentor to the volunteer coaches providing higher level / technical support.

#### 6. Implications for local people / service users

6.1 The proposals contained in this report will deliver significant benefits for local residents through the retention of much used community facility.

#### 7. Financial implications

- **7.1** Consultations on the financial implications have taken place with representatives of the Director of Finance, Property & Information Services.
- 7.2 Section 106 monies totalling £52,981 as a Public Open Space contribution are available to fund the provision of the scheme identified within this report through the S106 legal agreement established through planning permission planning application 2015/1302 Former Highfield Grange.
- 7.3 There is no time limit associated within the monies that have been received.
- 7.4 Expenditure identified within this scheme will be managed within the resources available.
- 7.5 The financial implications relating to this proposal are shown in Appendix A of this document.

#### 8. Employee implications

8.1 There are no employee implications arising through this proposal.

#### 10. Consultations
