Report of the Principal Officer (Licensing) to the meeting of the General Licensing Regulatory Board to be held on the 16th June 2010

Application to Renew the Sex Shop License for 462 Doncaster Road, Barnsley.

1.0 Purpose of the report

1.1 To place before Members an application from Pulse and Cocktails Limited for the renewal of their license to use the premises at 462 Doncaster Road, Stairfoot, Barnsley as a Sex Shop from the 17th March 2010.

2.0 Recommendation

2.1 That the license for 462 Doncaster Road be approved in accordance with the previous licenses that have been issued.

3.0 Background

- 3.1 The shop has been in operation at 462 Doncaster Road as Pulse and Cocktails for four years and the premises has operated as a sex shop for a considerable time prior to this.
- 3.2 There have not been any significant changes to the neighbourhood in the vicinity of the premises since the last application was made to renew the sex shop license.
- 3.3 Since the last licence was approved approximately twelve months ago there have been no complaints to the Licensing Section regarding the premises.

3.4 A copy of the application form, together with a list of Directors of the company are attached as Appendix 1.

4.0 Consultation

- 4.1 In accordance with the statutory requirements, notice of the renewal application has been published in a local newspaper on the 20th March 2010 and no objections/comments have been received by the Licensing Section.
- 4.2 South Yorkshire Police have raised no objections to the application.

5.0 Compatibility with European Convention on Human Rights

5.1 Approving the application, as recommended, will not involve interference with Convention rights.
