### REPORT TO THE HEALTH AND WELLBEING BOARD

# TRANSFORMATION WORKSHOP PLANNING

## 1. PURPOSE OF REPORT

1.1 The purpose of this report is to provide members will an update on the proposal to run a series of transformation workshops, over the course of a day, in September 2013. This will help to shape the future direction of health and social care services in Barnsley and is an integral part of the work around Inverting the Triangle and Home Truths.

# 2. **RECOMMENDATIONS**

It is recommended that:-

2.1 Members note the proposal to hold a transformation workshop day in September, to inform the strategic direction of health and social care services in Barnsley and identify appropriate representatives / participants.

#### 3. INTRODUCTION/BACKGROUND

- 3.1 The Health and Wellbeing Board received a report and presentation at its April meeting on the future strategic direction for health and social care services. Members agreed in principle the direction of travel around Inverting the Triangle and developments arising from Home Truths.
- 3.2 As part of the next stage of developments, a day of workshops will be scheduled for September 2013. This will allow key agencies (Barnsley Council, NHS Barnsley CCG, Barnsley Hospital NHS Foundation Trust and South West Yorkshire Partnership Foundation Trust) to share their transformation plans over the coming period.

### 4. SCOPE OF THE TRANSFORMATION WORKSHOPS

- 4.1 To ensure the vision for Inverting the Triangle can be translated into practical reality over the next 3-5 years, it is important that partners share their individual transformation plans to assess the current starting point and individual agency ambitions. This will allow the Health and Wellbeing Board to look holistically at the direction of travel for health, social care and well being in Barnsley and shape an agreed programme and associated series of activities towards the overall vision and blueprint.
- 4.2 The workshops will be designed to be as participative as possible, sharing plans and specific pieces of activity from an agency perspective to enable common/core elements to be pulled out and identified for collaboration and co-production i.e. the areas of overlap / cross agency work will effectively form the transformation plan for the HWB Board. It will also identify how a number of planned activities remain single agency focused, but ensure they are hooked into the wider transformation programme for health and social care.

4.3 The workshops will run over the course of a full day, with agency leads delivering their transformation plans to a wider audience with facilitation from the Acute Trust. This approach will enable an holistic perspective to be garnered and naturally pull together common themes and how they are to be taken forward.

## 5. NEXT STEPS/ WAY FORWARD

5.1 The Senior Strategic Development Group (executive of the Health and Wellbeing Board) will co-ordinate the planning for the workshops. Invitations and a programme will be sent out over the coming weeks to ensure the day can be prioritised accordingly.
