Procedure for Conduct of Hearings

Protocol for Hearings conducted by Licensing Sub-Committees

Each application that comes before a Sub-Committee will be considered individually, and this Licensing Authority will take its decision based upon:-

- The merits of the application.
- The promotion of the four licensing objectives (see below).
- The Policy Statement of the Licensing Authority, a copy of which can be obtained from www.barnsley.gov or the Licensing Office, 18 Regent Street, Barnsley.
- The guidance issued by the Secretary of State for Culture, Media and Sport on 7th July, 2004 under Section 182 of the Licensing Act 2003.

The four licensing objectives, as given by the Licensing Act 2003, are:-

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

The procedure for Licensing Sub-Committees is as follows:-

- Chair opens the meeting, introducing Members of the Sub-Committee and officers
 present to the applicant and members of the public, explains the nature of the
 decision to be taken, and the procedure to be followed.
- The Licensing Officer presents his report outlining the application, any relevant representations and relevancies to the Local Authority Licensing Policy Statement and Statutory Guidance.
- Members to ask any relevant questions of the officer (if any).
- Licensing Officer introduces applicant (if present) and invites him or her, or person representing them, to address the Sub-Committee to clarify any information arising from the Officers' outline, if necessary.
- Licensing Officer to invite those parties making representations to address the Sub-Committee.
- Members to ask any relevant questions of those parties making representations.
- [With the consent of the Sub-Committee (only) applicant or person representing them to ask any relevant questions of those parties making representations.]
- If necessary, the Sub-Committee will consider requests to allow other parties invited by the applicant to address it.
- Applicant or person representing them addresses the Sub-Committee.
- Members may ask any relevant questions of the applicant or person representing them.
- [With the consent of the Sub-Committee (only) parties that made representations to ask any relevant questions of the applicant or person representing them.]
- Chair to invite applicant or those representing them, and any parties making representations, to briefly² summarise their points if they wish.

¹ This Authority operates a presumption against cross-examination. If a party wishes to cross-examine another he must apply for the consent of the Sub-Committee, giving the reasons why he considers cross-examination to be necessary. If one party in a hearing is permitted to cross-examine, that right will be extended to all other parties.

² This Licensing Authority grants a maximum 20 minutes per party to make all relevant statements, but respectfully request that all parties keep points pertinent and the discussion moving in the interests of cost and efficiency.

- Chair asks all parties that they are satisfied they have said all they wish to.
- Members of the Sub-Committee discuss and make their decision.³
- Chair relays the decision and the reasons given for the decision, and any conditions placed upon the license (if granted) and the licensing objective that they relate to.

Please Note

- Any changes to the Membership of the Sub-Committee to that stated on the agenda will be given at the beginning of the meeting.
- Decisions will generally be taken regardless of whether the applicant is present.
 All notices and representations received from absent parties will be considered.
- Late representations and evidence will only be considered with agreement of all parties present.
- In cases where a decision cannot be given at the end of the hearing, the licensing officer will inform the applicant. They will then be notified of the decision within 5 working days.
- Parties have a right to appeal, details of which can be obtained via the licensing officer.
- This Council is committed to taking decisions in a honest, accountable and transparent fashion but on occasion may find it necessary to exclude members of the press and public based upon the legal framework given in the Local Government Act 1972 Schedule 12a and/or local policy. On these occasions decisions based on the above framework will be given.

³ The Sub-Committee will normally resolve to go into private session to consider its decision. Where it does so only the legal adviser will remain with the Sub-Committee and any legal advice which is given in private will be repeated in public.

LICENSING ACT 2003

APPLICATION FOR THE VARIATION OF A PREMISES LICENCE McDonalds Restaurant Limited, Old Mill Lane, Barnsley.

1. Background

- 1.1 During the introduction of the Licensing Act 2003 an application was made by McDonald's Restaurant Ltd for the McDonalds Restaurant Ltd, Old Mill Lane, Barnsley (the Premises) to Barnsley Metropolitan Borough Council (the Council) for a Premises Licence by conversion.
- 1.2 In January 2007 an application was received from McDonalds Restaurant Ltd to vary the Premises Licence.
- 1.3 Members are requested to determine the application to vary the Premises Licence, which seeks to vary the hours for the provision of Late Night Refreshment.
- 1.4 McDonalds Restaurant Ltd is a fast food restaurant located on a main arterial route out of Barnsley town centre. The premises resides on the perimeter of the Asda Superstore car park and has residential dwellings to one side. Due to the premises location the only access route for vehicles is a shared access with Asda which passes by residential properties.

2 Existing Premises Licence

2.1 A copy of the existing Premises Licence is attached as Appendix 1 and covers the following activities:

a) Late night Refreshment

Provision of late night refreshment is licensed for indoors only from 23.00 to 24.00 Monday to Sunday.

3 Existing Licence - promotion of the Licensing Objectives

The original conversion application contained very little information relating to the licensing objectives. The information provided is set out below:

a) General - all four licensing objectives

No information provided

b) The prevention of crime and disorder

No information provided

c) Public Safety

No information provided

d) The prevention of public nuisance

No information provided

Measures have been implemented to prevent noise nuisance

e) The protection of children from harm

No information provided

4 The Application to vary the existing Premises Licence

4.1 On the 22nd January 2007 an application was made to vary the Premises Licence for McDonalds Restaurant Limited, Old Mill Lane, Barnsley. This application relates to an extension of operating hours for licensable activities at the premises and an extension of the hours that the premises are open to the public. The details of which are specified below:

a) Provision of late night refreshment

Application to vary the premises licence has been made in respect of late night refreshment. The additional hours requested are for both indoors and outdoors and are from 23:00 on Friday, Saturday and Sunday nights through until 05.00 the following morning.

Note: the existing premises licence allows late night refreshment indoors only from 23:00 to 24:00 Monday to Sunday.

b) Hours premises are open to the public

Application to vary the premises licence has been made to allow the premises to open Friday, Saturday and Sunday from 23:00 until 05:00 the following morning.

5 Promotion of licensing objectives

5.1 The applicant has set out in the application the additional steps intended to be taken in order to promote the four licensing objectives, if the proposed premises licence is granted. These are transcribed and attached as Appendix 2.

6 Responsible Authorities

- 6.1 Representations have been received from the Senior Environmental Health Officer and her comments are attached as Appendix 3 and 3A.
- 6.2 No other representations have been received from responsible authorities.

7 Interested parties

- 7.1 Following publication of the statutory notice of the application to vary the premises licence in the local press (a copy of which has been provided to the Licensing Section by the applicant) and the display of notices at the premises representations have been received from six interested parties, five of whom live in close proximity to the premises, further details can be found on the location plan in Appendix 4. The representations were received within the consultation period.

This means the applicant and should be afforded the right to make oral representations at the meeting.

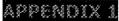

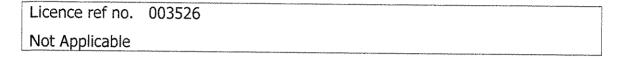

The Licensing Act 2003

The Prevention of Public Nuisance: A guide for licensees.

Pollution Control, part of Barnsley's Regulatory Services, produced this guide to help licensees in response to the Licensing Act 2003. The Act means that if you sell alcohol, provide entertainment or sell hot food late at night you will require a licence from the Council.

Before issuing a licence, the Council must be satisfied that the licensee can comply with the four key licensing objectives, one of which is the prevention of public nuisance.

Public nuisance can broadly be described as how the activity of a person in one premises affects the rights of others or interferes with other people's enjoyment of their own premises.

Whether an activity cases a public nuisance may depend upon:

- The nature of the activity causing the nuisance;
- The time of day or night when it occurs;
- · How long the activity lasts and how frequently it occurs; and
- How many people are affected by it.

Officers from Pollution Control are responsible for assessing if a licensee can demonstrate from the information provided on the application form that they can sufficiently control how their business may impact on others - other businesses, neighbouring residents and members of the public.

The Licensee can assist officers by providing comprehensive information within their application about:

- the nature of their premises;
- the nature of the licensable activity or activities to be undertaken there;
- the potential impact this may have on others; and
- the measures they propose to take to control any impact.

The application form to vary an existing licence requires that you detail only the additional measures you feel are necessary to control noise from your premises. These additional measures may be necessary if you are wishing to include a new activity that has noise implications, such as live entertainment, or extend the hours you operate an existing form of entertainment. If there is no significant or material change in your activities then your existing noise control measures may be adequate.

Noise

Noise emanating from a licensed premises may be direct and therefore come from a source which is controllable by the licensee, for example:

- Recorded or live entertainment, particularly where the sound is amplified;
- · Ventilation or air-handling units; or
- Beer deliveries and the disposal or recycling of bottles.

Noise may also occur as an indirect result of the licensable activity and, though the licensee may not be in direct control of the noise source, they can look to influence it. Examples include:

- Taxis and customers' vehicles (horns, engines and banging car doors); and
- Customers themselves, whether inside or outside the premises.

In order to control the noise associated with licensable activities carried out at your premises you should first consider how likely it is that noise may impact upon others (other businesses, nearby residents). This process can be described as a risk assessment. You should consider:

- The structure of your premises and its location, the proximity of any noise sensitive premises, the room or rooms where any licensable activity will take place, the position of any doors, windows, ventilation outlets; and
- The licensable activity, whether recorded or live, amplified or not, whether played inside and out and the hours you wish to be able to carry out.

For example, if your premises is surrounded by houses and you intend to have live music till 2a.m. five nights a week, there is a high risk that your business may cause a noise nuisance.

We would expect you to take all reasonable steps to ensure:

- a) that noise from your premises cannot be heard at noise-sensitive premises. Noise-sensitive premises may be those occupied by nearby businesses or residents. You will need to take extra care if:
- i) your premises is attached to another premises, to ensure noise and vibration do not pass through the structure, or
- ii) if you are applying for a licence to operate late at night (normally assumed to be after 11p.m. or when people could normally be expected to be asleep; and
- b) that noise does not cause unreasonable disturbance to other persons who may be passing by or using nearby public facilities.

The following is a "check list" of measures that you should consider taking to prevent noise from your business interfering with the rights of others. The list is not exhaustive. Which measures are appropriate for <u>your</u> business will depend on whether the operation of licensable activities at your premises poses a low, medium or high risk of noise affecting others.

- Ensure all windows and doors to the premises (or room(s) where entertainment is to take place) are kept closed while entertainment is in progress (except for access and egress).
- Ensure internal lobby doors to main entrances are kept closed and not propped open. (You may wish to consider fitting self-closers.)
- Ensure any air conditioning units are acoustically attenuated i.e. the noise coming from them has been reduced
- Ensure any ventilation outlets are acoustically attenuated, as where air can pass through, so can noise.
- Provide sound insulation to emergency exit doors.

NB: It is very important to ensure the premises is properly ventilated and emergency exits are kept clear. If a premises has air-conditioning the windows do not have to be opened to ensure adequate ventilation. You may also wish to consider "alarming" doors so that management or staff are alerted should emergency exits be opened for reasons other than an emergency.

- Keep speakers within the premises, and do not position them near to openings such as doors or windows.
- Do not deliberately play, or direct music outside the premises as a means of attracting custom.
- Ensure all amplified sound is played through a sound limiting device.
- Insist that performers and DJs use the in-house speakers rather than their own systems.
- Ensure any external air handling units or ventilation outlets are located where least likely for noise emanating from them will disturb others and are insulated to reduce the sound being transmitted.
- Provide anti-vibration mountings for all speakers.
- Ensure that deliveries, waste collections and the handling and recycling of glass bottles are not undertaken when local residents are likely to be asleep
- Restrict the hours when customers can use external areas such as beer gardens, children's play areas and timber decking
- Provide solid fencing/barriers around car parking, play areas and beer gardens
- Ensure all staff, DJ's and artists understand the measures you have proposed to control noise and the implications of not implementing them.
- Carry out sound checks prior to live entertainment commencing and undertake regular monitoring checks around your boundary or at the nearest noise sensitive premises to ensure noise is not excessive.

Remember you should include details of any additional measures you intend to take, to control noise from licensable activities, in your operating schedule, where these are considered necessary due to the variation you have applied for.

N.B. If you wish to be able to carry out occasional late night entertainment (perhaps to allow you to cater for birthday parties or weddings) you should consider notifying the Council in advance, in the form of a Temporary Event Notice, rather than applying for a variation to extend your normal licensing hours. For occasional events or hours extensions contact the Licensing Section for information about TENs.)

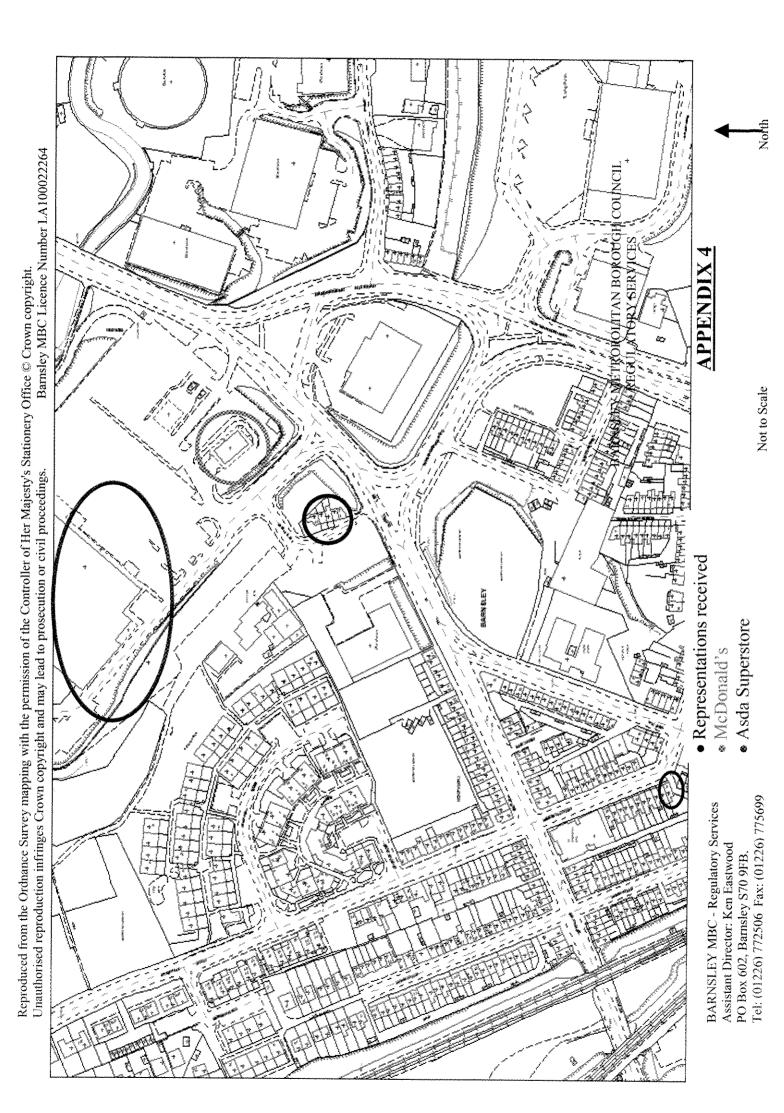

We would like to state our objections to the proposed extension of McDonald's weekend opening hours as we believe their will be a marked increase in the anti-social behaviour that already occurs at the weekends on and around McDonald's premises until they close at 12 midnight.

Bikers and boy racers use McDonald's as a meeting place to gather in large numbers also as a starting and finishing point for the time trials and street and road racing that occurs every weekend. While gathered outside McDonald's the boy racers sound their car horns constantly for up to two hours at a time, drive around McDonald's, the ASDA car park, along Canal Street and Canal Way screeching their tyres and performing "wheelies, donuts and handbrake turns," play music with the volume set at unacceptable levels, shout and scream abuse at one another, passers by and McDonald's employees. We also have high levels of noise and anti-social behaviour from the underage drinkers who use the forecourt outside McDonald's restaurant, the drinkers favourite night is Friday when they gather to shout, scream, fight and urinate.

On a Friday, Saturday and Sunday the town centre drunks use McDonald's until it closes at midnight. They shout, swear and urinate; the women also scream and fight. All the above anti-social behaviour also happens on and around our property and the areas leading to and from McDonald's, the weekends are the worst as the behaviour escalates into damaging our property including our car and an assault on myself by an underage drinker leaving McDonald's.

The above incidents and hundreds more have been reported to the police. I have spoken to McDonalds local and head office's, Councillors, various council departments including the environment, wrote numerous letters and attended all types of meetings over a twelve year period to try and resolve the problems that McDonalds brings us.
