APPLICATION FOR A PREMISES LICENCE

The Station Inn, 128 Doncaster Road, Darfield, Barnsley. S73 9JA

1. Background

- 1.1 In October 2007 an application was received from Mr. Roger William Smith and Mr. Kristen Lee Smith for a premises licence for The Station Inn.
- 1.2 Members are requested to determine the application for the Premises Licence.
- 1.3 The Station Inn is a public house situated on the main A635 Doncaster Road out of Barnsley. The premise facilitates a car park with a capacity of approximately twenty five vehicles, a large beer garden area and a separate smoking area. There are residential properties surrounding the premises.

2 Previous Premises Licence

- 2.1 The premises concerned in this application held a premises licence in the name of "The Goldmine"; this licence was surrendered in May 2007.

3 The Application for a Premises Licence

- 3.1 On the 1st October 2007 an application was made for a Premises Licence for The Station Inn, 128 Doncaster Road, Darfield, Barnsley. This application relates to the provision of regulated entertainment, the provision of entertainment facilities, the provision of late night refreshment and the supply of alcohol. The details of which are specified below:

a) Regulated Entertainment

The premises licence application has been made in respect of **Films, Indoor Sporting Events, Live Music and Recorded Music**. The hours requested for **Films** are for indoors only and are from 12:00 to 23:00 Sunday to Thursday, and 12:00 to 24:00 Friday and Saturday. The hours requested for **Indoor Sporting Events** are from 11:30 to 24:00 Monday to Sunday. The hours requested for **Live Music** are for both indoors and outdoors and are from 15:00 to 22:30 Monday to Thursday, 12:00 to 23:30 Friday and Saturday and 12:00 to 22:30 on Sundays. The hours requested for **Recorded Music** are for both indoors and outdoors and are from 12:00 to 23:00 Sunday to Thursday and 12:00 to 24:00 Friday and Saturday.

In addition, the application includes seasonal variations for **Live Music:-**

Bank Holiday Sundays additional 1 hour (inside 23:30).

New Years/Christmas Eve (Sun to Thurs) additional 2.5 hours (inside 01:00).

New Years/Christmas Eve (Fri & Sat) additional 1.5 hours (inside 01:00).

The application includes seasonal variations for **Recorded Music:-**

Bank Holiday Sundays additional 1 hour (inside 24:00 outside 22:00).

New Years/Christmas Eve (Sun to Thurs) additional 3 hours (02:00).

New Years/Christmas Eve (Fri & Sat) additional 2 hours (02:00).

In addition the application includes further details relating to **Live Music:-**

Folk groups and/or musical additions to organised functions, weddings, engagements, birthdays etc.

Outdoor barbeque/beer festival etc. (Sun to Thurs) music finish 21:00.

Outdoor barbeque/beer festival etc. (Fri & Sat) music finish 22:00.

The application also includes further details relating to **Recorded Music:-**

General background Music.

Disco or similar organised functions (weddings etc).

Outdoor barbeque/beer festival (Sun to Thurs) music finish 21:00.

Outdoor barbeque/beer festival (Fri & Sat) music finish 22:00.

b) Provision of entertainment facilities

The premises licence application has been made in respect of the **provision of facilities for making music** and the **provision of facilities for dancing**. The hours requested for **making music** are for indoors and outdoors and are from 12:00 to 23:00 Sunday to Thursday and 12:00 to 24:00 Friday and Saturday. The hours requested for dancing are for indoors only and are from 12:00 to 23:00 Sunday to Thursday and 12:00 to 24:00 Friday and Saturday.

In addition, the application includes seasonal variations for **Making Music:-**

Bank Holiday Sundays additional 1 hour (inside 24:00 outside 22:00).

New Years/Christmas Eve (Sun to Thur) additional 3 hours (02:00).

New Years/Christmas Eve (Fri & Sat) additional 2 hours (02:00).

In addition, the application includes seasonal variations for **Dancing:-**

Bank Holiday Sundays additional 1 hour (finish 24:00).

New Years/Christmas Eve (Sun to Thur) additional 3 hours (02:00).

New Years/Christmas Eve (Fri & Sat) additional 2 hours (02:00).

The application also includes further details relating to the provision of facilities for making music :-

Outdoor activities (Sun to Thurs) music finish 21:00.

Outdoor Activities (Fri & Sat) music finish 22:00.

c) Late Night Refreshment

The premises licence application has been made in respect of late night refreshment. The hours requested are for indoors and outdoors and are from 23:00 to 00:30 Sunday to Thursday and 23:00 to 02:00 Friday and Saturday.

In addition, the application includes seasonal variations for **Late Night Refreshment:-**

Bank Holiday Sundays additional 1.5 hours (finish 02:00).

New Years/Christmas Eve (Sun to Thur) additional 2.5 hours (03:00).

New Years/Christmas Eve (Fri & Sat) additional 1 hour (03:00).

d) Supply of Alcohol

The premises licence application has been made in respect of the provision of supply of alcohol. The hours requested are for consumption on and off the premises and are from 11:30 to 00:30 Sunday to Thursday and 11:30 to 02:00 Friday and Saturday.

In addition, the application includes seasonal variations for the **supply of alcohol:-**

Bank Holiday Sundays additional 1.5 hours (finish 02:00).

New Years/Christmas Eve (Sun to Thur) additional 2.5 hours (03:00).

New Years/Christmas Eve (Fri & Sat) additional 1 hour (03:00).

e) Hours Premises are open to the public

The premises licence application has been made to allow the premises to open from 09:30 to 01:00 Sunday to Thursday and 09:30 to 02:30 Friday and Saturday.

In addition, the application includes seasonal variations for the **hours premises are open to the public:-**

Bank Holiday Sundays additional 1.5 hours (finish 02:30).

New Years/Christmas Eve (Sun to Thur) additional 2.5 hours (03:30).

New Years/Christmas Eve (Fri & Sat) additional 1 hour (03:30).

4 Promotion of licensing objectives

4.1 The applicant has set out in the application the additional steps intended to be taken in order to promote the four licensing objectives, if the proposed premises licence is granted.

a) General – all four licensing objectives

Regular liaison/training with all members of staff to ensure compliance with all the licensing objectives and the Licensing Act 2003.

Co-operation with the police and BMBC Licensing Department.

b) The prevention of crime and disorder

Implement photographic proof of age scheme for anyone appearing to be under the age of 21.

Affiliation to the Pubwatch scheme.

Any person who appears to be intoxicated or behaving in an offensive/aggressive manner will not be served, and asked to leave the premises.

No smoking signs to be clearly displayed and all customers to comply with current legislation.

c) Public Safety

Compliance with current Health and Safety/ Fire Safety regulations.

No customers allowed behind the bar.

Portable fire extinguishers on the premises.

First Aid kit on the premises.

d) The prevention of public nuisance

During any organised function utilising either disco or live music, a designated member of staff to make regular assessments of the external noise levels and take steps to reduce the noise level should it be likely to cause disturbance to local residents.

Patrons will be requested to leave the premises quietly to avoid disturbance.

Taxis will be requested not to sound their horns on arrival and to park considerately.

e) The protection of children from harm

No person under the age of 16 unless accompanied by a person over the age of 18 will be permitted onto the premises when they are being used for the supply of alcohol.

No person under the age of 18 unless accompanied by a person over the age of 18 will be permitted on the premises after 21:00 hours when they are being used for the supply of alcohol.

No alcohol to be sold/served to persons under the age of 18.

5 Responsible Authorities

5.1 No representations have been received from any responsible authorities.

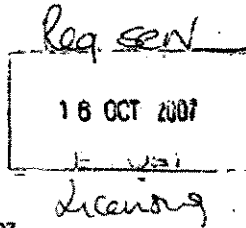

Application for a premises licence for The Station Inn 128, Doncaster Rd,
Darfield.

As interested parties my wife and I wish to object to the above. We object to the application for an outdoor music licence for the above premises. This will cause public nuisance because these premises are within a purely residential area. Many houses are within very close proximity to this public house including our own home. The granting of such a licence will cause noise intrusion into our homes and gardens. It is immaterial what hours the music is played as we are unable to take any steps to prevent this intrusion. It will directly affect the privacy and enjoyment of our homes and gardens.

We also object to the hours during which alcohol will be served. The hours applied for, particularly during Friday and Saturday, even more so on Bank Holiday Sundays and Christmas and New Year, both inside and outside, will cause a similar nuisance, especially if you consider some events such as beer festivals which are mentioned in the application. Even with music inside which continues to within a short time of closing, experience has shown that on warm evenings and the summer time the doors and windows of the public house are naturally opened and the music again is intrusive to a considerable degree. This will also fall under the heading of crime and disorder. My wife and I have twenty six years of experience of living at this address and are only too aware of the disorder which has occurred during much shorter drinking hours at these premises. Extension of the hours will only exacerbate the problem. That with the attendant noise of cars, taxis etc., and inebriated people leaving the premises in the early hours of the morning causing conflict between residents and customers of the premises.

There is also the question of safety. Outside events, such as described in the application, will on many occasions include the presence of children. The outside area of these premises open directly onto the very busy A835 via wide unprotected entrances.

In relation to the above application as an 'interested party' living within 60 meters of the said establishment I wish to make representation to the Licensing Authority in relation to the applicants Roger William Smith/Kristen Lee Smith application for the granting of an outdoor music licence for the grounds of the above establishment.

The premises is within a Residential area and therefore the granting of such a licence for outdoor music is liable to lead to a substantial degree of 'Public nuisance' in that the disturbance to immediate residents would be neither welcome or acceptable.

As an 'Interested party' I have also discussed this with my immediate neighbours Mr and Mrs Whittaker, 21 Doncaster Road; Mr and Mrs Whinstanley 25 Doncaster Road and Mr Upperdine and Mr and Mrs Upperdine Jnr 29 Doncaster Road. They are all of the opinion that the granting of this music licence for outdoors would be detrimental to the well-being of the immediate residents.

The issue of 'Public Safety' as applicable to the Health and Safety at Work Act 1974 relating to 'Risk Assessments' 1990 can not be guaranteed in that the venue for the music is directly on to a major Trunk Road between Doncaster and Barnsley. The issue falls into two sections; One it will cause disruption to the flow of traffic and Secondly, the public attending such an event, whilst consuming alcohol are only partitioned from a major traffic flow by a 1.5 meter wall.

The issue of noise in relation to children must also be examined and considered. The above establishment's boundary wall is also the wall between the houses in Howard Street. A number of residents have families with children under the age of ten years. The granting of such a licence could not be seen as meeting the standard of 'Protection of Harm' in relation to children in that systematic deprivation of sleep could be construed as child abuse.

Finally the granting of a late night licence for alcohol up to 02.00 hours will result in the slamming of car doors; taxi's sounding horns, even though it is illegal after midnight and possible arguments within a Residential area after midnight. Once again causing disruption and disharmony within a settled community.

Further to your notice for the above applicant to supply alcohol, the provision of regulated entertainment/facilities and the provision of late night refreshment.

I would like to express my objections regarding this as follows:

There are only 26 parking spaces for the pub, where would any overspill go. Parking on Balkley Lane and Howard Street is already over congested as it is without extra parking from pub clientele.

There are over 50 children within a 100 yard radius of the pub, late night music would only disturb the essential sleep needed for them to achieve well at school.

In a quiet community, this end of Darfield has, we feel we should not be subject to the late night rowdiness that this would attract and feel that it would have a vast detriment to a close knit community.

This is not a town centre environment where facilities like this are catered for but a village environment which consists of a spectrum of residents from the very young to the very old who should not be subjected to the proposed night time activity.

We would relish the opportunity of a meeting to be held with the residents about any movement on the pubs future uses.

We live directly adjacent to the Station Inn, and have had damage to our car, experienced people urinating and vomiting on our property and also bottles, glasses and cigarettes being strewn around our premises. This would be exacerbated by the late opening hours.

2. Public Safety

We have had direct conflict with customers in the past who have behaved in a threatening manner towards us. This is usually due to excessive amounts of alcohol.

3. The Prevention of Public Nuisance

- a. We are very concerned to read the proposals for music being played both indoors and outdoors until late night/early morning, as we are able to hear even loud conversation due to the closeness of our home to the pub.

As this is a quiet residential area we feel that we would lose a quiet village pub to be replaced by a night club.

- b. The opening of a smoking area to the rear of the pub is another concern. This area was previously a private area, and as it joins our garden boundary wall we would be concerned of further noise, litter and loss of privacy.
- c. As previously experienced we have had issues with Taxis picking up customers of the pub. Whilst we have seen that the Taxis would be asked not to sound their horn, we have found that this is not the case. We also have the added noise of car doors slamming, and rowdiness of customers awaiting pick up. Whilst we can cope with this up to eleven o'clock at night at weekends we feel that extended opening would further disturb our and our children's sleep.

4. The Protection of Children from Harm


We have two children under the age of 14, who have complained about the noise from the pub on certain occasions, when it has disturbed their sleep.

We also feel that the extended opening hours would attract a different clientele, that again is more suited to a nightclub, and which could have a detrimental effect on our children.

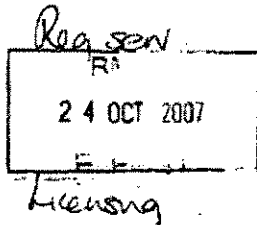
