- 1.1 The Local Government Boundary Commission (LGBCE) agreed the council's proposal in July 2023 to maintain the current number of members at the council at 63.
- 1.2 For the next phase of the review the LGBCE have invited the council and other interested parties to submit their proposals for future ward boundaries. The deadline for these submissions is 29 January.
- 1.3 The submission should be based on the electorate as we believe it will be in 2029 taking into account natural population growth and new housing

developments.

1.4 Future ward boundaries should ensure that no ward electorate differs from the average by more than 10%.
