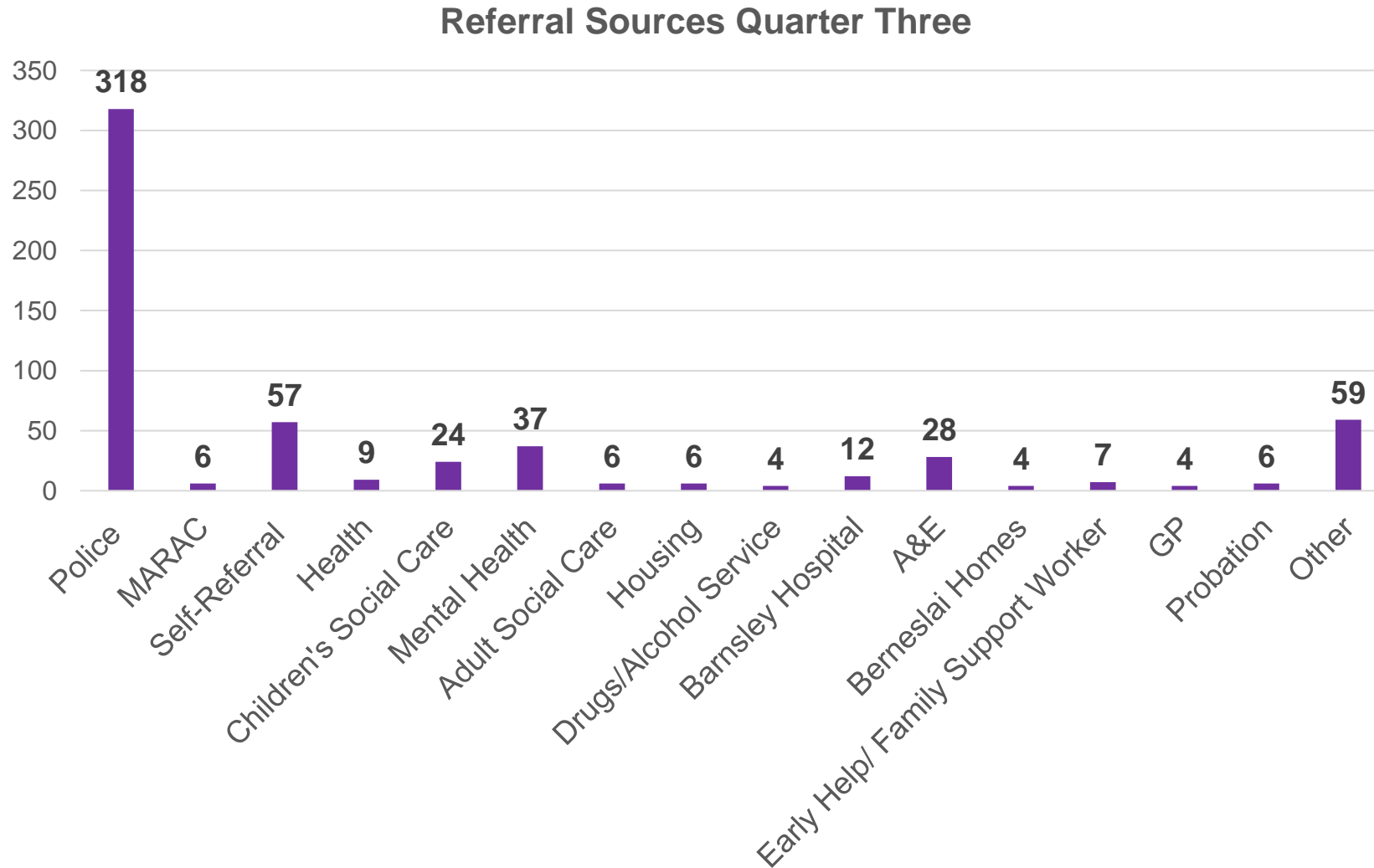

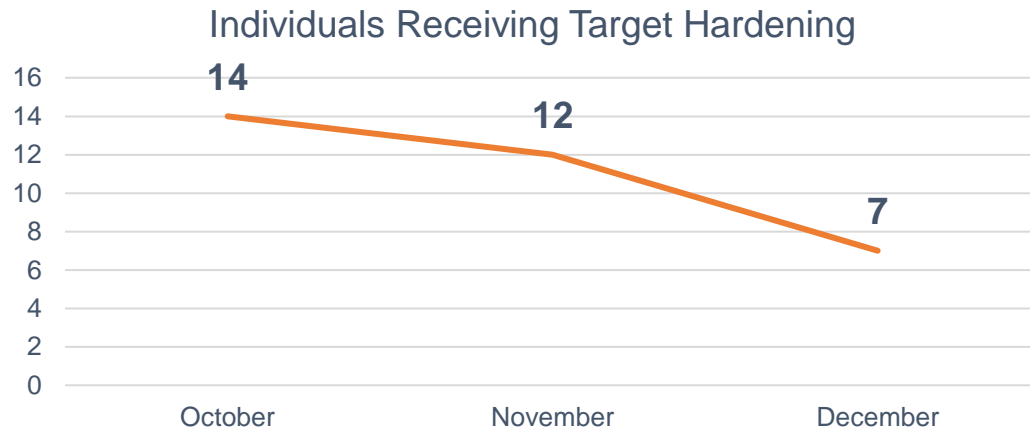

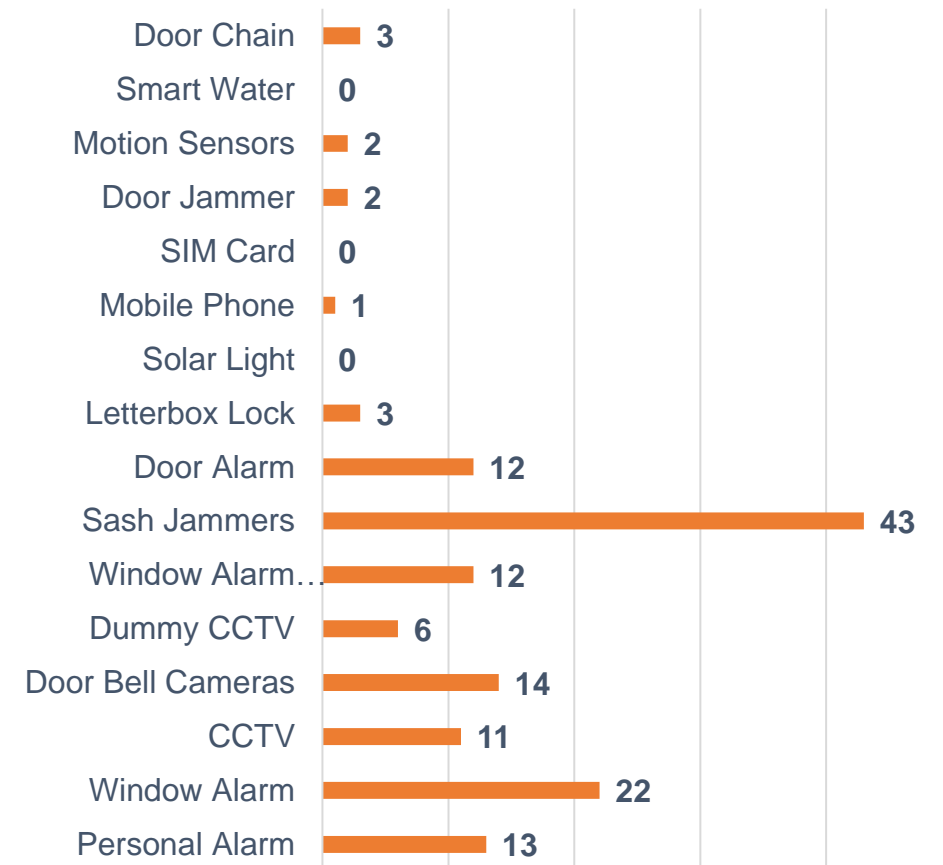
1. IDAS: Domestic abuse service







The service has provided 143 target hardening items to 33 individuals in Quarter Three.

IDAS have a contract with a service to fit target hardening items and repairs to make people's homes more secure. If individuals supported by the service reside in Berneslai Homes properties, IDAS support fitting target hardening. IDAS also deliver target hardening stock to the Berneslai homes depot so they can fit the items as and when they receive a referral from IDAS.

Target Hardening Items Provided in Quarter 3

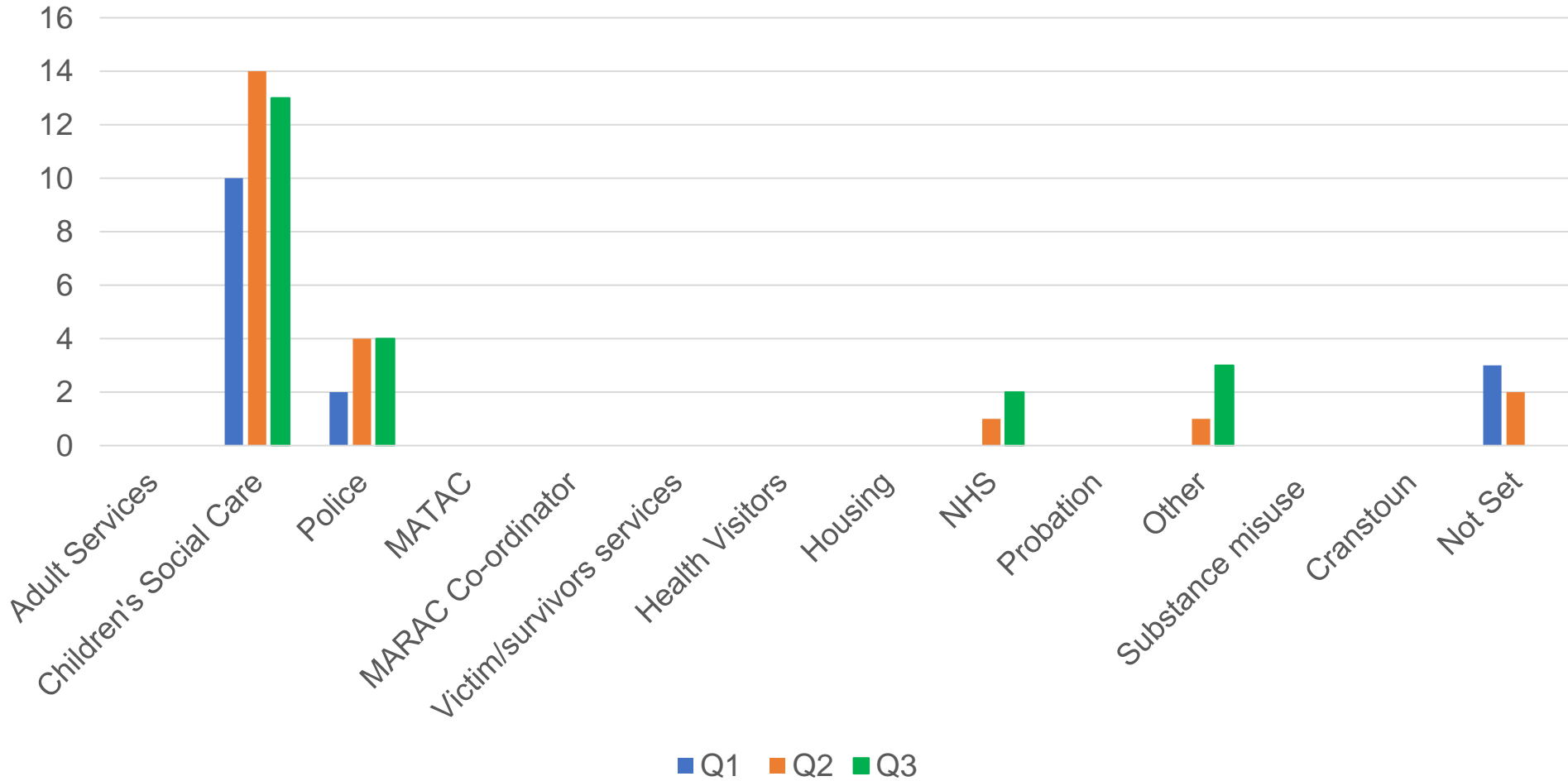

Inspire to Change Referral Sources

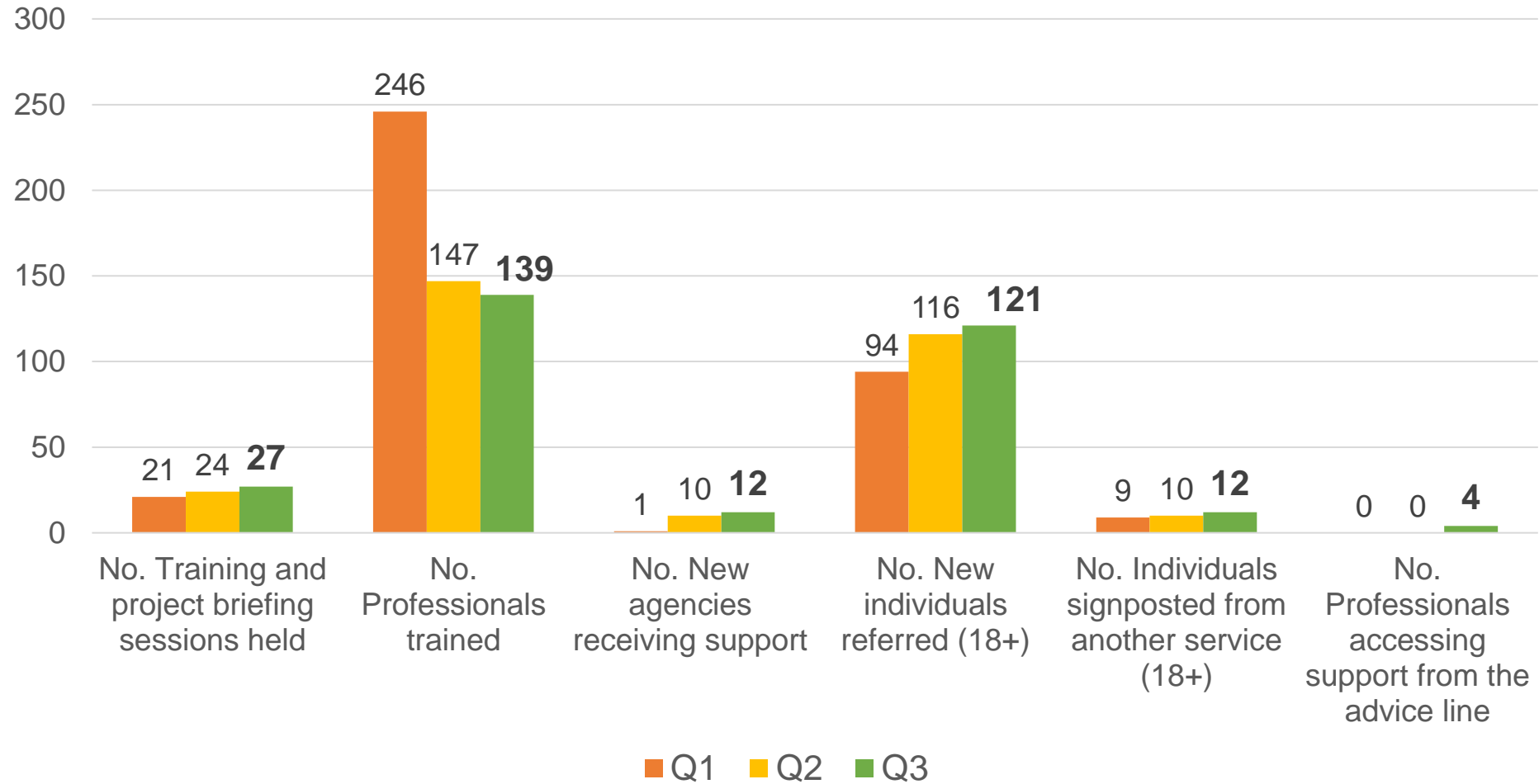

Exceptions

A number of indicators are on red showing a negative direction of travel, but exceptions are only reported where it is felt the Safer Board needs to be aware.

- Although there has been a slight increase in the percent of repeat domestic abuse cases submitted to MARAC this quarter (30% in quarter three). This remains towards the lower end of the Safelives recommended range of 28-40%.
- The number of professionals training for Ask the Question reduced. This is because initially awareness raising training was delivered to multi-agency groups. The service is now offering single service training to ensure individual agencies are ready to Ask the Question and provide data. This means there is no reduction in the amount of training but in the numbers of staff accessing it which is fully expected.
- The number of referrals made to Adults and Children's Social Care from IDAS decreased slightly. As did the number of referrals from Children's Social Care to IDAS. The Safe and Together training programme may help with this.
