LICENSING ACT 2003

APPLICATION FOR A PREMISES LICENCE Old School House (formally known as the Polish Club), Blackburn Lane, Barnsley

1 Background

- 1.1 On 14 October 2016, a valid application under the provisions of the Licensing Act 2003 was received from Mr Barrie Treanor of 98 Intake Lane, Barnsley.
 - A copy of this application is attached as Appendix 1.
- 1.2 Members are requested to determine the application for a premises licence.
- 1.3 The premise is located within close proximity to a residential area and currently operates under both a Club Premises Certificate and a separate Premise Licence granted by a Statutory Licensing Sub-Committee panel on 1 November 2013.
- 1.4 A copy of the existing Club Premise Certificate and Premise Licence are set out in Appendix 2.

2 Application for Premises Licence

2.1 The proposed application requests the licence takes effect as soon as possible and requests the following licensable activities and opening times:

a) Plays

Monday to Sunday 11.00 - 02.00 both indoors/outdoors

b) Films

Monday to Sunday 11.00 - 02.00 indoors only

c) Indoor Sporting Events

Monday to Sunday 11.00 - 02.00

d) Live Music

Monday to Sunday 11.00 - 00.00 both indoors/outdoors

*Outdoor music to cease at 22.00

e) Recorded Music

Monday to Sunday 11.00 - 02.00 both indoors/outdoors

*Outdoor music to cease at 22.00

f) Performance of Dance

Monday to Sunday 11.00 – 02.00 both indoors/outdoors

g) Anything of a Similar Description

Monday to Sunday 11.00 - 02.00 both indoors/outdoors

h) Late Night Refreshment

Monday to Sunday 23.00 - 02.00 both indoors/outdoors

i) Supply of Alcohol

Monday to Sunday 11.00 – 02.00 both indoors/outdoors

*No drinks permitted outdoors after midnight

j) Opening Times

Monday to Sunday 11.00 - 02.30

3 Promotion of Licensing Objectives

3.1 The applicant has set out the steps intended to be taken in order to promote the four licensing objectives, subject to the proposed premises licence is granted.

a) General – all four licensing objectives

The licensing objectives have been considered in the light of the proposed application, taking into account the venue and the site location.

Details of any measures considered necessary to promote the licensing objectives are contained under the relevant objective below.

b) The Prevention of Crime and Disorder

'Pubwatch.

Challenge 25.

Zero tolerance to drugs on premises'

c) Public Safety

'Not serving people deemed to be already drunk.

Regular patrolling of premises'.

d) The Prevention of Public Nuisance

'Soundproof venue.

Doors and windows closed where feasible'.

e) The Protection of Children from Harm

'Children must be accompanied at all times.

Must be off premises by 9pm.

Staff are CRB checked'.

4 Responsible Authorities

4.1 A representation has been received from the Pollution Service as a Responsible Authority involved in this process, as set out in Appendix 3.

Mr Denton has objected to the grant of the licence on the grounds of public nuisance, citing continual complaints received in respect of the premise. To alleviate issues raised, Mr Denton has recommended conditions be attached to the licence restricting the number of outdoor events permitted to take place (one per month) along with the submission of a noise management plan, subject to the licence being granted in this case.

4.2 Members are minded to note that the applicant has accepted both conditional requests, in addition to ceasing alcohol sales at 00.00 (as opposed to 02.00), closure of the premise at 01.00 (as opposed to 02.30), ceasing indoor music at 23.45 (as opposed to 02.00 in respect recorded music & 00.00 in respect of live music) and ceasing outdoor music at 21.00 (as opposed to 22.00).

5 Interested Parties

- 5.1 Following publication of the statutory notice of the application for the premises licence in the local press and the display of notices at the premises, a number of representations have been received from interested parties. In total, 6 representations have been received.

- 5.3 Valid representations which relate to one of more of the four licensing objectives are attached as Appendix 4.
- 5.4 Under the provisions of the Licensing Act 2003, representations can be made by anyone whether or not they live or have a business interest within the vicinity of the premises where the application has been made. However, in this case interested parties concerned do reside close to, if not within the immediate vicinity of where the application has been made.
- 5.5 Each representation sets out a number of areas for concern in relation to the licensing objectives and a précis these are provided overleaf:
 - a) 'Issues between staff at the club, crowd control and arguments with residents simply trying to relax at home'
 - b) 'The premise does not follow the terms of the current licence. Current licence states no drinking outside the premise at 11pm, this is not adhered to as people are outside until the early hours on most weekends'
 - c) 'Current licensing hours cause enough noise pollution and antisocial behaviour and extending these hours will only make it worse'
 - d) 'My house is directly opposite the doorway of the building, and as such I already tolerate unacceptable levels of noise from patrons of the club as they enter/leave and congregate outside in the smoking shelter area'
 - e) 'Currently I can hear music and voices through closed windows in my home'
 - f) 'You can hear live music given how loud it is, with the extended opening hours this is likely to increase and keep me awake at night'

6 Compatibility with the European Convention on Human Rights

The decision of the panel will amount to a determination of the Council and the rights of the applicant. Therefore, as far as it is possible to do so, the panel must comply with the requirements of Article 6 (the right to a fair trial). This means the applicant and should be afforded the right to make oral representations at the meeting.

If Members determine to refuse the application, it is necessary for the reasons to be clearly stated.

A police constable or an authorised officer (e.g. a Council licensing officer) may require such person who has custody of the club premises certificate (i.e. the nominated person, as referred to above) to produce the certificate for examination.

Offences

The secretary of the club commits an offence if he fails to comply with the above requirements relating to a club premises certificate and/or a club premises summary. Anyone who has custody or control of the club premises certificate (i.e. the holder of the club premises certificate or such other nominated person, as referred to above) commits an offence if they fail, without reasonable excuse, to produce the licence in accordance with a requirement under the above duty to produce. A person guilty of an offence under section 57 is liable on summary conviction to a fine.

LICENSING ACT 2003

Licence refine

1. Supply of Alcohol

Where this Licence authorises the supply of alcohol the following conditions will apply:

- a) No supply of alcohol may be made under the premises licence
 - i) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - ii) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

2. Door Supervision (except theatres, cinemas, bingo halls & casinos)

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:
 - Be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
 - ii) Be entitled to carry out that activity by virtue of section 4 of the Act.
- 2. But nothing in subsection (1) requires such a condition to be imposed:
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licences authorising plays or films);
 - (b) in respect of premises in relation to:
 - i) Any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - ii) Any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.
- 3. For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

3. Exhibition of Films

- 1. Where this licence authorises the exhibition of films, the licence includes a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.

3. Where -

- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- 4. In this section "children" means any person aged under 18; and

"Film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984 (c39) (authority to determine suitability of video works for classification).

4. Irresponsible Promotions (On Licenced Premises only)

- 1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - b) Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which causes a significant risk of undermining a licensing objective.
 - c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective.
 - d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favorable manner.

5. Dispensing of Alcohol Directly into the Mouth (On Licenced Premises only)

The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

6. Tap Water (On Licenced Premises only)

The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.

7. Age Verification Policy

- The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol,
- 2) The Designated Premises Supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either a holographic mark or an ultraviolet feature.

8. Measures (On Licenced Premises only)

The responsible person shall ensure that-

- 1) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i) beer or cider: ½ pint:
 - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (b) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

9. Alcohol Pricing and Duty

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1 -

"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (a)

"permitted price" is the price found by applying the formula -(b)

$$P = D + (DxV)$$

Where -

- P is the permitted price. (i)
- D is the rate of duty chargeable in relation to the alcohol as if the duty were (i) charged on the date of the sale or supply of the alcohol, and
- V is the rate of value added tax chargeable in relation to the alcohol as if the (iii) value added tax were charged on the date of the sale or supply of the alcohol;

"relevant person" means, in relation to premises in respect of which there is in force a (c) premises licence -

the holder of the premises licence, (i)

- the designated premises supervisor (if any) in respect of such a licence, or (i)
- the personal licence holder who makes or authorises a supply of alcohol under (ii) such a licence:
- "relevant person" means, in relation to premises in respect of which there is in force a (d) club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- "value added tax" means value added tax charged in accordance with the Value (e) Added Tax Act 1994.
- Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from (f) this paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of (g) (1) paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of (2) alcohol which take place before the expiry of the period of 14 days beginning on the second day.

I have looked at the application for the above premises and I can confirm that based on the times of the application and the fact that outside entertainment has been requested I object on the grounds of public nuisance. The above premises is one that I have been greatly involved in over the past few years due to continuing noise complaints. These complaints have related to both internal music form live bands and noise from patrons outside. There are already a number of restrictions on the existing licence that were added at a hearing to control the outbreak of noise. Unfortunately due to the sensitive location of the premises, I do not feel that it is suitable to allow outdoor entertainment without it being restricted to a set number of events per year. In addition I would request that the minimum of one month prior to an outdoor event taking place notification is given to Pollution Control along with the submission of a written noise management plan. With regards to the extension of the hours of operation within the premises I have concerns that this is greatly more than what is within the current PL, again I feel that due to the sensitivity of the location being so close to residential properties that I object on the ground of public nuisance.

I wish to make representations about the proposals made by Barrie Treanor to Barnsley Metropolitan Council for a variation of licence to a premises licence in respect of the Old School House, Blackburn Lane, Barnsley S75 2BA on the following terms:

Sale of alcohol Monday to Sunday 11am-2am

Regulated entertainments Monday to Sunday 11am-2am.

Following a successful meeting with Barrie, his colleague Gary and two residents from Blackburn Lane I highlighted my concerns:

- The level of noise from the club from people drinking and smoking outside. This on occasions goes on until around midnight. The noise worsens the later it gets.
- 2) The level of noise from live bands and that this varies, 5ome bands are barely heard and others are heard inside my property when all doors and windows are closed. This I believe is in breach of the current licence agreement.
- 3) The litter of glass bottles left on Blackburn Lane. The flower bed outside my property is used as a rubbish bin. I shared my concerns that children attending Summer Lane primary school play on the walls around the flower beds. Therefore, I clean the bottles away on a regular basis to prevent accidents.
- 4) Underage drinking and how this is challenged and dealt with within the club.
- 5) Crowd control and drinking in the smoking area.

Barrie and Gary took my concerns on board. I agreed I would be happy for the club to open earlier however opening later I did not feel was conducive to a residential area. We discussed how loud the band was on the 14.10.16 and the crowd outside the club. There were issues between staff at the club, crowd control and arguments with residents simply trying to relax at home. The police were called on this occasion. The following Friday was a repeat but unfortunately attracted underage drinkers. I have no evidence to suggest they were served in the club however they were drinking in and around the flowers beds outside my home. Screaming and shouting and generally making a

nuisance of themselves. I acknowledge this level of disruption doesn't happen every weekend but would not be willing to take the risk of opening into the early hours of the morning.

) therefore object to the club staying open until 2 am and would prefer to stay with the current closing hours to avoid a potential increase to crime and disorder, antisocial behaviour and noise pollution which has been on the increase of late. I did however take on board the passion that Barrie and Gary have for the club and would be happy for it to open earlier at weekends.

I am writing to make representation about the application made by Barrie Treanor for a variation to the premises licence in respect of The Old School House (The Polish Club) on Blackburn Lane, for both the sale of alcohol to be served during the hours of Monday - Sunday 11am - 2am and to have regulated entertainment Monday - Sunday 11am - 2am.

I strongly object to this application as I currently feel the premises do not follow the terms in the current licence to which they hold. I have enclosed a copy of a letter in which myself and other residents received follow the meeting at Barnsley Town Hall when the current licence was granted, I've included this to refer to and highlight what is not been followed up on.

The current licence states no drinking outside of the premises after 11pm, this is not been adhered to as people are outside until the early hours on most weekends.

It states that live and recorded music (indoors only) to play only until 11.30pm, again this on occasions this may go on to past midnight.

Additional conditions, states all external doors and windows to be kept closed whilst live or recorded music is taking place, my wife has taken photographic evidence on numerous occasions showing the doors are clearly wedged open and presented it to both Barnsley councils noise pollution and licensing departments to which nothing ever came of it, I can appreciate a photo does not prove music was been play played at the time taken, but surely too either depart could also appreciate she wouldn't have wasted the time and effort highlighting the issue if this was not the case. The letter also state in additional conditions that a competent member of staff makes regular checks around the boundary to establish if amplified music can be heard beyond the premises boundary (boundary been the wall around the premises I presume), yet again this does not happen as we are able to hear it from inside our property, we have again also complained about this to both noise pollution and the licensing departments only to be told that both departments feel the levels we have to endure at times is that of an acceptable level, surely any level heard within the walls of my property particularly with our windows closed is classed as not ensuring that noise can be heard beyond the premises boundary as stated in the letter. We have also been told by both departments that we are the only residents on the street that seem to have an issue with noise levels and that complain, yet having spoke to other residents and friend of the street they too still experience disturbances from the noise heard coming from within the premises of The Polish Club and too have complained on numerous occasions.

Finally stated in the in addition, the Sub Committee paragraph b) states, recommended that the centre work with residents to ensure that any problems and issues which come to light can be addressed and overcome. I myself have rung the Polish Club when I felt the noise levels were unacceptable and asked that a member of staff come over to my property and listen from inside, and was flatly refused and told, the council say the levels they have the systems set at are acceptable and that's what I am leaving them at.

In addition to this on numerous occasion at the weekends there is a burger van set up in the grounds of the Polish Club, again something myself and other residents of the street don't wish to have to experience, not only do we not want the additional noise of its generator but we don't appreciate having the smell coming into our homes particularly when you have windows open.

I am writing this as a formal objection to the proposed changes to the license granted for the building formerly known as the Polish Club on Blackburn Lane.

My house is directly opposite the doorway of the building, and as such I already tolerate unacceptable levels of noise from the patrons of the club as they enter/leave and congregate outside in the smoking shelter area. Loud and crass language is normal over a weekends activities, and to allow this to go on into the early hours would cause unacceptable disturbance in a residential area. The volume of music from within the venue is also a concern. Some evenings are better than others, and I recognise that money has been spent over the last 12 months to dampen the noise audible outside the perimeter, but between the music and the noise from those outside, I would be extremely disappointed to learn that this has been extended until after midnight. Currently I can hear music and voices through closed windows in my home, but just accept it at present knowing that by midnight it will have more than most likely have died down.

Another concern is the age and supervision of the target audience of the venue, who are looking to appeal to music lovers and especially of college age. Youths are regularly attracted to the site, and I do have issues with challenge 25 principles not being adhered to or enough door management, both to keep nuisance noise levels down, crowds under control and glasses and bottles being kept inside.

Having met Mr Treanor and Mr Watson with other residents of Blackburn lane, I have been able to voice my objections in person and look at alternatives. I have stated that I do not have any issue with the earlier trading being given the go ahead, my objection is the late night/early morning license. At the meeting we discussed the apparent lack of understanding around challenge 25, and both parties agreed to research and implement a better understanding for themselves and their staff. The location of the smoking shelter itself was debated, and they agreed that the current dishevelled look of the building would be dealt with. Mr Treanor and Mr Watson also discussed possible plans for the future of the business, including current building work to the interior, but had no clear and agreed path of how the building would eventually be used.

I do not wish for this building to be unused and run into a state of disrepair. I do wish the current owners luck in their business. What I do not wish is for residents unfortunate enough to live opposite the building to be subjected to unnecessary noise at an unacceptable time of night. Putting a license to do this, which is most akin to nightclub hours- in a residential area is senseless and insensitive to local people who could support a reasonably run venture in the future.

I am writing to you in relation to the proposed opening times for the Polish Club on Blackburn Lane which I was told about by a neighbour. I was informed that a small laminated piece of paper had been affixed to a lamp posts across the opposite side of Blackburn which I feel does not adequately convey such a message to the residents.

I was expecting such a message to be sent to all residents or appear in the Barnsley Chronicle. Can it be confirmed if this information was communicated via the local newspaper please, if so what dates did this appear and can a copy be supplied to me?

I have also seen recently that the venue has had a burger van on the premises, can it be confirmed if the Polish club is to serve food be that inside it or externally as a take-away. I cannot recall seeing such information being advertised to support the Polish club in relation to the existing or proposed license regarding the application for opening hours?

I understand that renovations are taking place within the Polish club, will this include air conditioning? On hot and humid nights will revellers currently spill outside and are noisy. If air conditioning is going to be provided has an application to the council be applied for?

Given that the opening of the Polish club extends on Blackburn Lane currently I would like to see the gate being permanently closed or sealed. I would also like to see some form of noise reduction applied externally from the wall to the Polish Club itself as currently this is where revellers congregate.

At the moment you can hear live music given how loud it is, with the extended opening hours this is likely to increase and keep me awake at night. How is the Polish Club going to reduce such noise for residents?

Is there only going to be specific nights of live music can it be confirmed what nights these are please?

Currently there have been empty glasses and disused food on Blackburn Lane and surrounding area therefore what additional refuse bins will be put in place to reduce such litter? Asking revellers to keep such litter within the Polish Club grounds does not seem to be working.

Is there going to be any regular monitoring put in place by Barnsley Council to ensure that residents can be satisfied this venue will not negatively impact the surrounding area, if so what are these checks, frequency and will such findings be available to residents?

i have been a resident for many years and over the last two years there has been an increase in traffic, noise and drunken behaviour from revellers of the Polish club. How is the council going to combat the amount of traffic on Blackburn Lane? I have observed the volume of traffic and it has been had to park-up outside my own door, can Blackburn Lane be made residents only on one side to assist the residents?

I feel that with the opening hours of 11pm to 2am Monday to Sunday will increase the noise levels and of drunkenness in the locality. Blackburn Lane is a quiet residential area which does not need this as there are many pubs and other entertainment venues in close proximity to serve the general population without the need for the change in opening hours for the Polish Club.

I am personally not in favour of the hours being extended for the reasons stated as it will only serve to negatively impact the area around Blackburn Lane and surrounding locality.

i do hope that my views will be taken into consideration when considering the application for extended hours of the Polish club. I know that others within Blackburn Lane are of the same opinion as to how negatively it will cause an impact.

Please respond to the questions within this letter and confirm that it has acknowledged in response to opposing the extension of the licence.

Hook forward to seeing a response in relation to the above.
